- The closing date for applications is 5.00pm on Friday 14 October 2022. No late applications will be accepted;
- The application will be assessed by the Biala Wind Farm Community Fund S355 Committee:
- The eligible target community for the Community Fund is outlined in the Biala Wind Farm Community Fund Project Guidelines;
- Applications must include at least two quotations that are less than six months old.
- Applications must include a Financial Management Plan;
- Funding will not be provided for sponsorship and/or day-to-day expenses of local sporting bodies, however, larger infrastructure items will be considered;
- Applications must not profit individuals or private entities;
- You will be notified of the success or otherwise of the application in November with funds released in December:
- At the completion of the project you will be required to provide a summary report
 of costs including copies of tax invoices, together with photos of the completed
 project (where applicable);
