

Mayor's Gunning Flood Relief Appeal Fund Rules

1. Background

The Mayor's Gunning Flood Relief Appeal is limited to the single natural disaster (as part of AGRN1034 severe weather and flooding event) caused by flood / storm event in Gunning main street and adjacent surrounding streets for property damage sustained on Monday, 31 October 2022.

2. Purpose

The Mayor's Gunning Flood Relief Appeal Fund has been established as a public fund to provide financial relief for persons in Gunning who were directly impacted in necessitous circumstances by the flood event on 31 October 2022.

A person will be in necessitous circumstances where his or her financial resources are impacted by a natural disaster. Necessitous circumstances in this case was the result from a disaster in Gunning caused by flood and/or storm damage event.

All funds were raised by the Upper Lachlan Shire Council local government area community and will be distributed by Council to support people in Gunning whose properties/business/homes were directly impacted by the flood event.

3. Expression of Interest for Financial Assistance

Council will advertise and accept a single round of applications seeking financial assistance related to the damage caused by the disaster event. A one-off payment may be approved per household.

4. Payment of Monies

Council will release funds upon satisfactory evidence of sustained damage from the "event". Evidence is to be supplied by the applicant as part of an Expression of Interest form. All payments shall be made by electronic funds transfer (EFT) from Council to an individual. There is no restrictions imposed on the applicant on the use of funds that are released by Council.

5. Record Keeping

An accurate account of monies received and monies expended shall be kept for audit purposes by Council staff in Council corporate record management system and accounting software system.

6. Disbursements Committee

Funds will be released and distributed in an equal amount to eligible households as a one-off payment. The funds released is limited to the quantum of funds that were received from the Appeal fund raising.

The Mayor's Gunning Flood Relief Fund Committee consists of the Mayor, Deputy Mayor and Management Executive and they shall approve, disburse and make payments to:-

- A Individual person in Gunning who have suffered loss as a result of the disaster.
- A property owner in Gunning who have suffered loss as a result of the disaster.
- A property tenant in Gunning who have suffered loss as a result of the disaster.

The decision on disbursements by the Mayor's Gunning Flood Relief Appeal Fund Committee is final and binding.
